

6th RUN4FUN GARDA TRENTINO - 2026 REGULATIONS

Trentino Eventi s.s.d.a.r.l., with the patronage of the municipalities of Riva del Garda, Arco, and Nago-Torbole, is organizing the **6th RUN4FUN GARDA TRENTINO**, a recreational and physical activity event open to all, male and female, ages 0 to 99, covering a distance of approximately 4 km. The event has been approved and included in the national CSI (Italian Sports Center) calendar.

RUN4FUN GARDA TRENTINO will take place on **Sunday, November 8, 2026**, in Garda Trentino, **starting at 9:00 a.m. from the Casa del Dazio in Torbole sul Garda (TN)**. The event will take place along the lake side path from Torbole sul Garda to Riva del Garda, on a route entirely closed to traffic. The organization reserves the right to vary the start time by a few minutes, for example, due to organizational and/or television requirements.

RUN4FUN GARDA TRENTINO will have a **limited number of 400 participants** and will take place in all weather conditions.

1) **PARTICIPATION REQUIREMENTS**

RUN4FUN GARDA TRENTINO 2026 is a recreational and physical activity event over a distance of approximately 4 km. Males and females aged 0 to 99 may register. Registration for the event implies a tacit self-certification of physical fitness for recreational and physical activity, as required by applicable legislation. Minors may participate only if they present a signed authorization from their parent or guardian, available on the website www.trentinoeventi.it.

2) **REGISTRATION**

Registration is open **from March 1, 2026 to October 31, 2026** (registration must be completed by October 20, 2026 to receive a personalized bib with a maximum of 30 characters), **subject to early closure upon reaching 400 athletes**.

Trentino Eventi s.s.d.a.r.l. reserves the right to close registrations early or accept registrations after the closing date at its sole discretion.

Any unregistered athletes will not be allowed to participate and/or join the race route, under penalty of immediate disqualification. In the event of an accident, they will be reported to the police.

3) **REGISTRATION FEES**

€18.00 from March 1st to April 30th *

€23.00 from May 1st to June 30th *

€28.00 from July 1st to August 31st *

€33.00 from September 1st to October 31st *

€12.00 for children up to 10 years old

***subject to the maximum number of 400 participants being reached**

4) **"CHARITY" REGISTRATION FEES**

(The "CHARITY" fee of €2.00 will be donated, along with the doubling of the same amount made by our company, to an association indicated among those found on our website under the Charity Program heading at www.trentinoeventi.it)

€25.00 from May 1st to June 30th *

€30.00 From July 1st to August 31st *

€35.00 From September 1st to October 31st *

€12.00 for children up to 10 years old

Note: Registrations are not permitted on race day.

5) THE REGISTRATION FEE INCLUDES

- Participation in all tastings on Friday and Saturday;
- Free breakfast for athletes and their families on race day;
- Personalized bib number if registered by October 20, 2026 (maximum 30 characters);
- Insurance and medical care;
- Race pack containing products offered by sponsors;
- Short-sleeved technical jersey;
- Medal for all finishing athletes.
- Shuttle bus from the PalaFiore to Torbole – start area;
- Shuttle bus from the finish area to the PalaFiore;
- Bag storage service in Torbole – start area and transportation to the PalaFiore;
- Changing room and showers at the PalaFiore.

6) REGISTRATION PROCEDURE

Note: The cost of online registration fees (not dependent on the organization) is not included in the indicated fees.

- **Online registration.** Registration is only possible on the website www.trentinoeventi.it by bank transfer, VISA and MasterCard credit cards, or PayPal.

7) REGISTRATION VALIDATION

Registrations without the participation fee will not be accepted. The registration fee will be calculated based on the date of payment.

8) REGISTRATION DEADLINE

Registration **will close at 11:59 PM on October 31, 2026, unless the maximum number of 400 participants is reached.** Registrations received after this deadline will not be accepted. The organizers reserve the right to close registrations early or accept registrations after the closing date at their sole discretion.

Any early closure (e.g., due to a sold-out event) will be announced on the website www.trentinoeventi.it.

Registrations will not be accepted on the day of the event.

9) REGISTRATION CONFIRMATION

You can check the status of your registration for RUN4FUN GARDA TRENTINO 2026 on the website www.trentinoeventi.it. A few days before the race, all registered athletes will receive an email notification that serves as an official "confirmation letter." This email will contain all the essential instructions for picking up your race bib, the participation prize, and participating in the race. It is not necessary to print a paper copy of the email itself; it can be presented on a device such as a smartphone or tablet.

10) BIB AND PARTICIPATION PRIZE COLLECTION

Registered participants can pick up their race bib and participation prize at the PalaFiore, Hall B2, at Via Baltera, 20 in Riva del Garda:

- Friday, November 6, 2026, from 3:00 PM to 7:00 PM
- Saturday, November 7, 2026, from 10:00 AM to 7:00 PM
- Sunday, November 8, 2026, from 7:00 AM to 8:00 AM

To pick up the participation prize, participants must present the voucher included in the envelope containing their race bib. Race bibs and participation prizes may also be collected by third parties with a written authorization, a confirmation letter from the person delegating the race, and a photocopy of an identification document.

Race bibs are strictly personal, cannot be tampered with, or reduced, and are not transferable, under penalty of disqualification.

11) DELEGATION TO COLLECT THE RACE BIB AND PARTICIPATION PRIZE

If you are unable to collect your race bib and participation prize, you may delegate another person in writing, who must present the following documentation:

- a) Signed Confirmation Letter;
- b) Delegation Form (to be attached to the Confirmation Letter);
- c) Photocopy of a valid identification document.

12) RACE BIB

The participant, or their parent if a minor, is responsible for the ownership and safekeeping of their race bib, and is entitled to use all the services mentioned in these regulations and/or subsequently communicated. Tampering with or reducing the race bib, or obscuring wording and/or symbols, is prohibited, under penalty of disqualification.

Anyone who, without proper registration, participates without a bib and/or a counterfeit bib, or otherwise does not conform to the assigned bib, in addition to being held responsible for damage to persons or property, including themselves, will incur sporting sanctions under the jurisdiction of federal and criminal law bodies (Article 624 of the Italian Criminal Code and/or Article 640 of the Italian Criminal Code and/or Article 650 of the Italian Criminal Code).

13) SHUTTLE

From 7:15 a.m. to 8:15 a.m., a free shuttle service will be available for athletes and their companions. It will connect Riva del Garda – EXPO Area at the Palafiere in Via Baltera with Torbole, the bus stop 100 meters from the Run4Fun start.

14) TIME MEASURES

As this is a free-paced recreational and physical activity event, no final ranking will be drawn up and no times will be recorded.

15) TIME LIMIT

The time limit, within which race services will be guaranteed, is 1 hour.

16) MEDICAL SERVICE

Adequate medical assistance will be provided along the route and at the start and finish points.

17) FINISH

After crossing the finish line, athletes will be directed into designated corridors, receive a finisher's medal, and be allowed access to the final refreshments. Returning to the finish line and/or stopping to wait for other competitors at or immediately after the finish line are prohibited.

19) DATA PROCESSING REGULATIONS

Pursuant to Article 13 of Legislative Decree No. 196 of June 30, 2003, we hereby inform you that:

- a) the data contained in the registration form is required for registration, to prepare the list of participants, the ranking, and the historical archive, to perform the services stated in the regulations, to send informational materials about the GARDA TRENTINO HALF MARATHON 2026 and subsequent editions, and to send information and commercial offers from its partners and sponsors;
- b) the consequences of failure to provide the aforementioned data or information will be non-admission to the event;
- c) the rights of the interested party regarding the processing of personal data are listed in Article 7 of the aforementioned Legislative Decree No. 196/03. At any time, the interested party may consult, modify, or delete their data free of charge by writing to the data controller at Trentino Eventi s.s.d.a.r.l.

20) IMAGE RIGHTS

The athlete registered and participating in the event, including on behalf of a minor of whom they are a parent or guardian, declares that they have no claims against Trentino Eventi s.s.d.a.r.l. and/or its assignees and/or successors in title, and in general against anyone who uses and exploits their image and/or the image of the minor they accompany during their participation in the RUN4FUN GARDA TRENTINO 2026 in group situations and for the purpose of documenting the event. All claims of the athlete are satisfied by the opportunity to participate in the sporting event.

21) CANCELLATION

If the RUN4FUN GARDA TRENTINO 2026 is canceled and/or not held for reasons beyond the control and/or control of the organizers, including the revocation of permits by the competent public authorities, the registered participant will have no claims against Trentino Eventi s.s.d.a.r.l. or other co-organizers, including reimbursement for expenses incurred or incurred. Signing the registration form constitutes a waiver of any claim for damages and/or compensation and/or any claim for compensation and/or satisfaction for any financial loss suffered or being suffered. Registration is non-refundable, non-postponable, and non-transferable.

22) CHANGES

The Organizing Committee reserves the right to amend these regulations at any time due to changes to the regulations, current legislation, or participation criteria (for example, whether or not to sign agreements), whether due to health regulations, requests from

local authorities or public safety authorities, or for reasons deemed appropriate for better organization of the race. Any changes to schedules, services, and locations will be communicated to registrants in the confirmation letter and/or on the website www.trentinoeventi.it.

23) ATHLETE DECLARATION

"I declare that I know and comply with the RUN4FUN GARDA TRENINO 2026 regulations published on the website www.trentinoeventi.it, drawn up in accordance with current legislation.

I am aware that participating in RUN4FUN GARDA TRENINO 2026 and/or sporting events in general is potentially risky.

I further declare that I register voluntarily and am responsible even if a minor, of whom I am the parent or legal guardian, is registered by me. I assume all risks arising from my participation in the event: falls, contact with vehicles, other participants, spectators, or others, weather conditions, including scorching heat, extreme cold and/or humidity, traffic and road conditions, any type of risk that is well known and assessed by me, and any consequences resulting from illnesses and/or injuries suffered or caused to myself or others, even if attributable to inadequate physical condition, that may occur. before, during, and after participating in the event.

I therefore hereby waive, now and in the future, on behalf of myself and the minor of whom I am a parent or guardian, any claim for compensation or damages in relation to the above. I release and discharge, to the fullest extent permitted by applicable mandatory regulations, the RUN4FUN GARDA TRENINO 2026 Organizing Committee, Trentino Eventi s.s.d.a.r.l., the promoters, the Municipal Administrations of Arco, Riva del Garda, Dro, and Nago-Torbole, the Provincial Administration of Trento, the Regional Administration of Trentino Alto Adige, all Sponsors and Partners of the event, and their respective representatives, successors, officers, directors, members, agents, and employees of the aforementioned companies, from all present and future claims or liabilities of any kind, known or unknown, arising from my participation in the event and from that of anyone participating under my responsibility.

Once registration has been accepted, RUN4FUN GARDA TRENINO 2026, I understand that the participation fee is non-refundable, even in the event of cancellation.

I further grant my authorization to all the entities listed above to use photographs, tapes, videos, images on the website, and anything related to my participation in the event for any legitimate use without compensation.
