

7th AGS KIDS GARDA RUN - 2026 REGULATIONS

Trentino Eventi s.s.d.a.r.l., with the patronage of the Municipality of Riva del Garda, Arco, Nago-Torbole is organizing the **7th AGS KIDS GARDA RUN**, a free-paced recreational road race open to young males and females aged 0 to 14, approved and included in the national CSI (Italian Sports Center) calendar.

The AGS KIDS GARDA RUN will take place on **Saturday, November 7, 2026, in Piazzale Segantini in the historic center of Arco**, with **the first start at 3:00 PM**. The organizers reserve the right to vary the start time by a few minutes, for example, due to organizational and/or television requirements.

The AGS KIDS GARDA RUN 2026 **will have a limited number of 300 participants** and will be held in all weather conditions.

1) REGISTRATION

Registration is open **from March 1, 2026 to October 31, 2026** (until October 20, 2026 to receive a personalized bib with a maximum of 30 characters), **subject to early closure upon reaching 300 athletes.**

Trentino Eventi s.s.d.a.r.l. reserves the right to close registrations early or accept registrations after the closing date at its sole discretion.

2) AGE OF PARTICIPATION

Registered males and females will be divided into three groups based on age:

2026 – 2021: approximately 400 meters – 1 lap *

2020 – 2016: approximately 800 meters – 2 laps *

2015 – 2012: approximately 1,200 meters – 3 laps

* Parents may run with their children

3) **REGISTRATION PROCEDURES**

- a) Registrations can be made **from March 1, 2026 to October 31, 2026** (by October 20, 2026 to receive a personalized bib with a maximum of 30 characters), on the website www.trentinoeventi.it by bank transfer, VISA and MasterCard credit card or Paypal, **subject to early closure when 300 athletes are reached.**

Note: The cost of online registration fees (not dependent on the organization) is not included in the indicated fees.

- b) At the PalaFiere Pavilion B2 at Via Baltera, 20 in Riva del Garda, **subject to bib availability**, on the following days:

- Friday, November 6, 2026, from 3:00 PM to 7:00 PM
- Saturday, November 7, 2026, from 10:00 AM to 2:00 PM

Trentino Eventi s.s.d.a.r.l. reserves the right to close registrations early or accept registrations after the closing date at its sole discretion.

Any unregistered athletes will not be able to participate and/or join the race course, under penalty of immediate disqualification. In the event of an accident, they will be reported to the police.

4) **REGISTRATION FEE**

The registration fee is €10 until October 31, 2026, **unless the race closes early once the number of 300 registered participants has been reached.**

5) **THE REGISTRATION FEE INCLUDES:**

- Personalized bib if registered by October 20, 2026 (max 30 characters);
- Assistance along the route and at the finish line;
- Long-sleeved cotton jersey;
- Final refreshments;
- Medal for all finishers;
- Insurance and medical assistance;
- Shuttle bus from the PalaFiere to Arco – start area;
- Shuttle bus from the finish line to the PalaFiere.

6) **REGISTRATION DEADLINE**

Registration **will close at 11:59 PM on October 31, 2026, unless the maximum number of 300 participants is reached.** Registrations received after this deadline will not be accepted. It will also be possible on Saturday 7th only if there are bibs available.

The organizers reserve the right to close registrations early or accept registrations after the closing date at their sole discretion.

Any early closure (e.g., due to sold-out status) will be announced on the website www.trentinoeventi.it.

7) **REGISTRATION CONFIRMATION**

You can check the status of your registration for the AGS KIDS GARDA RUN 2026 on the website www.trentinoeventi.it. A few days before the race, all registered athletes will receive an email that serves as an official "confirmation letter." This email will contain all the essential instructions for picking up your bib, your participation prize, and participating in the race. It is not necessary to print a paper copy of the email itself; it can be presented on a device such as a smartphone or tablet.

8) RACE NUMBER AND PARTICIPATION PRIZE COLLECTION

Registered participants can collect their race bib and participation prize at the PalaFiere Pavilion B2, Via Baltera, 20 in Riva del Garda:

- Friday, November 6, 2026, from 3:00 PM to 7:00 PM
- Saturday, November 7, 2026, from 10:00 AM to 2:00 PM.

To collect the participation prize, participants must present the voucher included in the envelope containing the race bib. Race bibs and participation prizes may also be collected by third parties with a written authorization, a confirmation letter from the person delegating the race, and a photocopy of an identification document.

Race bibs are strictly personal; they may not be tampered with, reduced, or transferred to anyone else, under penalty of disqualification.

9) DELEGATION TO COLLECT THE RACE BIB AND PARTICIPATION PRIZE

If you are unable to collect your race bib and participation prize, you may delegate another person in writing, who must present the following documentation:

- a) Signed Confirmation Letter;
- b) Delegation Form (to be attached to the Confirmation Letter);
- c) Photocopy of a valid identification document.

10) RACE BIB

The registered participant, or their parent if a minor, is responsible for the ownership and safekeeping of their race bib, and is entitled to use all the services mentioned in these regulations and/or subsequently communicated. Tampering with or reducing the race bib, or obscuring wording and/or symbols, is prohibited, under penalty of disqualification.

Anyone who, without proper registration, participates without a bib and/or a counterfeit or otherwise non-compliant bib, in addition to being held responsible for damage to persons or property, including themselves, will incur sporting sanctions under the jurisdiction of federal and criminal law bodies (Article 624 of the Italian Criminal Code and/or Article 640 of the Italian Criminal Code and/or Article 650 of the Italian Criminal Code).

11) TIME RECORDING

As this is a free-paced recreational and motorsport event, no final ranking will be drawn up and no times will be recorded.

13) CANCELLATION

If the AGS KIDS GARDA RUN 2026 is canceled and/or not held for reasons beyond the control and/or control of the organizers, including the revocation of permits by the competent public authorities, the registered participant will have no right to claim anything from Trentino Eventi s.s.d.a.r.l. or other co-organizers, including reimbursement for expenses incurred or incurred. Signing the registration form constitutes a waiver of any claim for damages and/or compensation and/or any claim for compensation and/or satisfaction for any financial loss suffered or being suffered. Registration is non-refundable, non-postponable, and non-transferable.

14) SHUTTLE

Free shuttle service to the starting point in ARCO and back to the PalaFiere. Buses will depart from the PalaFiere from 1:30 PM to 5:00 PM.

15) DATA PROCESSING REGULATIONS

Pursuant to Article 13 of Legislative Decree No. 196 of June 30, 2003, we hereby inform you that:

- a) The data contained in the registration form is required for registration, to prepare the list of participants, the rankings, the historical archive, to perform the services stated in the regulations, to send informational materials about the AGS KIDS GARDA RUN 2026 and subsequent editions, and to send information and commercial offers from its partners and sponsors.
- b) Failure to provide the aforementioned data or information will result in non-admission to the event.
- c) The rights of the interested party regarding the processing of personal data are listed in Article 7 of the aforementioned Legislative Decree No. 196/03. At any time, the interested party may consult, modify, or delete their data free of charge by writing to the data controller at Trentino Eventi s.s.d.a.r.l.

17) ATHLETE DECLARATION

"I declare that I know and comply with the AGS KIDS GARDA RUN 2026 regulations published on the website www.trentinoeventi.it, drawn up in accordance with current legislation.

I am aware that participating in the AGS KIDS GARDA RUN 2026 and/or sporting events in general is potentially risky. I also declare that I am registering voluntarily and am responsible for any registration of a minor, of whom I am the parent or legal guardian.

I assume all risks arising from my participation in the event: falls, contact with vehicles, other participants, spectators, or others, weather conditions, including scorching heat, extreme cold and/or humidity, traffic and road conditions, any type

of risk that is well known and assessed by me, and any consequences resulting from illnesses and/or injuries suffered or caused to myself or others, including those attributable to inadequate physical condition, which may occur before, during, and after participating in the event.

I therefore declare that I waive, now and in the future, on behalf of myself and the minor of whom I am a parent or guardian, any claim for compensation or indemnity in relation to the above.

Being aware of the above, in consideration of the acceptance of my registration, I release and discharge, on behalf of myself and the minor of whom I am a parent or guardian, to the fullest extent permitted by applicable mandatory regulations, the Organizing Committee of the AGS KIDS GARDA RUN 2026, Trentino Eventi s.s.d.a.r.l., the promoters, the Municipal Administrations of Riva del Garda, Arco, Dro, and Nago-Torbole, the Provincial Administration of Trento, the Regional Administration of Trentino Alto Adige, CSI, ASI, UISP, FIDAL, and all regional and territorial branches, all Sponsors and Partners of the event, their respective exemptors, successors, officers, directors, members, agents, and employees of the aforementioned companies. I hereby release myself from all present and future claims or liabilities of any kind, known or unknown, arising from participation in the event and from the participation of those who participate under my responsibility.

Once registration for the AGS KIDS GARDA RUN 2026 has been accepted, I understand that the participation fee is non-refundable, even in the event of cancellation.
